2017-2018 Pre-Kindergarten Extended Day Tuition Schedule

NYC Pre-K for All (PKA) hours are 8:30 – 2:50 Monday through Friday excluding holidays and pre-kindergarten non-attendance days. NYC Dept. of Education pays Battery Park City Day Nursery (BPCDN) a maximum of \$12,020 per child per year. The following fees apply to BPCDN private school pre-k programming outside of the PKA class time. PKA students are under no obligation to enroll in BPCDN private programming.

These tuition rates apply to contracts made for the entire Academic Year (September – June). Short-term contracts made for less than the 10 month Academic Year are subject to additional fees and restrictions. Please see a school administrator for details.

PKA Holiday & Non-attendance Days (approximately 10 full day and 2 half day Pre-K non-attendance days)
8:00 – 6:00 \$175 per day **OR** \$1750 per year (savings of at least \$300)

- Holiday & Non-Attendance Day private program space is limited to a “first come” basis. Yearly Rate must be paid entirely in September with **no** refund for missed days or contract changes.
- A non-refundable, non-transferable, one-time **Application Fee of \$75.00** is due when your child attends the BPCDN private program for one partial or one full day. This fee is only due for pre-k students who did not attend BPCDN previously.
- A **\$400 Enrichment Fee** is due when submitting a BPCDN contract each year. The Enrichment Fee is a flat annual fee and will not be adjusted for short term contracts. This fee is also due for any child who attends more than 1 partial or 1 full Drop-in day.
- One month’s prepaid tuition is due when submitting a BPCDN contract and will be held on account. The prepaid tuition will be credited to you upon completion of the Contract. It is forfeited if contract is cancelled after May 9, 2017.
- Preferred method of payment is Electronic Funds Transfer (EFT) originated by BPCDN (no additional processing fees are added). Payments by cash, personal check or bank check are subject to a \$30 per payment Processing Fee. Credit card payments are not accepted.
- **\$1.00 per minute late pick up fee will be charged after 2:55 p.m. (PKA dismissal) or 6:00 p.m. (After school dismissal). Fee is paid directly to BPCDN personnel who are watching your child.**
