If your schedule is decreased, the prepaid tuition differential will be forfeited. **If you cancel this Contract after March 16, 2018 or do not attend the indicated dates, you will forfeit the prepaid tuition.** You are responsible for all tuition due up to your child’s last day at the School.

Tuition cannot be reduced or refunded due to the absence of your child for any reason, at any time, during the term of this contract. There will be no substitution for days missed. All costs incurred in the collection of tuition, including but not limited to legal fees, are the responsibility of the Parents. The School reserves the right to terminate this Contract at any time.
